Why the Supreme Court Should Hear the DOMA Lawsuit

Now that the U.S. Court of Appeals for the First Circuit in Boston has struck down the Defense of Marriage Act (DOMA), the Supreme Court should quickly agree to hear the case. In its DOMA ruling, the lower appellate court practically begged the high court for guidance on how judges should assess the constitutionality of laws that treat individuals differently because of their sexual orientation.

In some ways, the Supreme Court has had it both ways in matters related to the constitutionality of laws that withhold benefits or impose burdens based on the sexual orientation of individuals. In 1996, the Court struck down a Colorado constitutional provision that denied LGBT individuals (and no others) legal

protection from discrimination. Seven years later, the Court found unconstitutional a Texas statute that criminalized consensual same-sex sexual intimacy. But the Court in neither case clearly explained how other laws that treat LGBT individuals differently because of their sexual orientation should be assessed under the Constitution. It is now time for the Court to speak on that issue.

Many of us have been arguing for a long time that lesbians and gay men satisfy the Court's own criteria for determining when to apply heightened (or rigorous) judicial review to laws that treat individuals differently because of who they are. The long history of discrimination that lesbians and gay men have suffered, for exam-

ple, justifies judicial protection. In addition, it is widely accepted that sexual orientation does not affect the ability of individuals to contribute to society. We all know that there are lesbians and gay men who are doctors, lawyers, scientists, engineers, and even members of Congress. This means that courts should be particularly skeptical of laws that target individuals because of their sexual orientation.

In its ruling striking down DOMA, the First Circuit did not find it necessary to address the question of whether lesbians and gay men are entitled to heightened judicial protection. Nonetheless, after pointing to the Supreme Court's own gay rights cases, it concluded that laws which treat individuals differently because of their sexual orientation must, at the very least, be subject to a meaningful form of judicial review that denies those laws a strong presumption of constitutionality.

One of the factors that the Supreme Court is supposed to take into account in deciding whether to hear a case is the extent to which there is a need to provide guidance to lower courts on a particular question of federal law. Although defenders and supporters of DOMA agree on little, both sides should agree that we need to clear up the confusion regarding how courts should assess constitutional challenges to laws that treat individuals differently because of their sexual orientation.

The lesbian and gay plaintiffs in the First Circuit DOMA lawsuit are either currently married or were married before the deaths of their same-sex spouses. The legal issue in the case, therefore, is not whether the plaintiffs have a constitutional right to marry. Instead, the issue is whether the federal government can deprive the tens of thousands of married same-sex couples the hundreds of rights and benefits that it makes available to heterosexual married couples. The nation desperately needs guidance from the Supreme Court on the question of whether this kind of brazen differential treatment is consistent with our constitutional values of equality and fairness.

See You at the Movies

It wasn't that long ago that John and Carl set off to see the South Florida premiere of *Black Swan* (at FLIFF). Until then, this film had played only a handful of "select markets" and was surrounded by interesting buzz: It was simultaneously scary and cerebral. It was for balletomanes, and those not all that interested in ballet. It was a mainstream movie, which included a Lesbian subplot. And it was superb.

Created on a shoestring budget of \$13,000,000 (which forced the star to give up her trailer allowance so that Fox Searchlight Pictures could afford to hire an onset medic to care for her concussion and fractured ribs), this independent film went on to earn almost \$107 million, making it not just a commercial success, but a true phenomenon as well.

It won an Oscar and a Golden Globe for Natalie Portman, and the American Film Institute Award for Movie of the Year, along with winning or being nominated for another 118 International Cinema Awards.

Directed by **Darren Aronofsky**, and co-written by Aronofsky with **Mark Heyman**, **John McLaughlin** and **Andres Heinz**, *Black Swan* picks at our deepest fears. In most scary movies, danger lurks in the shadows. Here it is devilishly grinning in the mirror. It is pure horror mixed with backstage melodrama. **Natalie Portman's** multiple awards-winning performance, **Benjamin Millepied's** distinct choreography*, and Aronofsky's high-flying style of directing make *Black Swan* one of the best films of 2010.

From FOX Searchlight: "Nina (Portman) is a ballerina in a New York City ballet company whose life, like all those in her profession, is completely consumed with dance. She lives with her obsessive former ballerina mother Erica (**Barbara Hershey**) who exerts a suffocating control over her. When artistic director Thomas Leroy (**Vincent Cassel**) decides to replace prima ballerina Beth MacIntyre (**Winona Ryder**) for the opening production of their new season, *Swan Lake*, Nina is his first choice. But Nina has competition: a new dancer, Lily (**Mila Kunis**), who impresses Leroy as well.

Swan Lake requires a dancer who can play both the White Swan with innocence and grace, and the Black Swan, who represents guile and sensuality. Nina fits the White Swan role perfectly, but Lily is the personification of the Black Swan. As the two young dancers expand their rivalry into a twisted friendship, Nina begins to get more in touch with her dark side -- a recklessness that threatens to destroy her."

And through it all is a "Greek chorus", the piano accompanist played by **John Epperson**, more famously known as "Lypsinka" -- who actually accompanied many prima ballerinas (including Dame Margot) in the 80's and 90's.

Even the famous score (by Tchaikovsky) is slightly distorted by Aronofsky and **Clint Mansell**, adding to the bizarre and intense transformation at the finale.

From IMDb.com: "From top to bottom, this film is at the height of what it means to be true art in cinema...If you get the opportunity...see it, it's harrowing and at times difficult to watch, but that combination of beauty and horror makes it impossible to turn away...It is a must-see for anyone who lives and breathes movies."

For many reasons (profanity, drug content, violence, strong hetero and lesbian sexual content) **this film is Rated R.**

It runs 108 minutes, leaving us time to talk about it over dinner afterwards.

We'll screen *Black Swan* at 4PM, Monday, July 16th, at the Pride Center.

*Of course, like the film itself, the release of the DVD was not without controversy. Another dancer claimed that most of Portman's dancing was not her own. This was finally settled when a scene-by-scene examination turned up the following: According to IMDb.com "there are 139 dance shots in the film. Out of the 139, 111 are untouched shots of Natalie Portman and the remaining 28 are her dance double, **Sarah Lane**. Of the shots in which Lane is featured, 26 of the 28 are wide shots and rarely appear on screen longer than one second. The two remaining shots required digital face replacement so the audience sees Portman's face instead of Lane's." (*One wonders when Lane will work in Hollywood again?*)

MIRROR MIRROR ON THE WALL --
*do we ever see ourselves at all...
or as others do?*

I had been eating properly, working out daily and dropped a few pounds. Finishing my gym routine I was relaxing in the 'wet' area of my health club and as I went from pool to sauna to steam, noticed that several people had been looking my way. Convinced my hard work was showing, I took one last, slow stroll throughout to bask in my new found fame and headed for the showers. I cranked on the water full blast and was ready to proudly bare my new physique to anyone who might wander in. It was only when I reached down to untie my shorts and there was no string that I realized all those "admiring glances" were only because I had my swim trunks on backward.

In addition to my first full-time job after college, I worked some part-time gigs to help pay off my student loans. One of which was as the night time Santa at a very fine local department store. The store went all-out for Christmas including a Santa suit so exquisite that it concealed my identity from everyone who knew me. One evening when my dad's boss and his wife came into the holiday area, I gave them the usual "Ho ho ho" greeting, called them by first names and although they had both known me from birth, neither had a clue as to who was playing Santa. social norms would be considered mentally challenged. Always clean and neatly dressed, he obviously suffered some degree of intellectual incapacitation. He would come in every evening, say "Hello Santa" and stand off to the side for several hours just watching as the other younger children had their pictures taken with the man in the red suit. This went on for several weeks but all vanished with the New Year. Early one evening the following June, some last minute problems at work had made me late for a reserved court to play racquetball. Unable to play in a three-piece suit and tie, I grabbed my gym bag from the car and dashed up the steps of the local YMCA totally unaware of anyone nearby. As I threw open the door to go inside I heard a familiar "Hello Santa" and turned to see the same young man who had been my nightly visitor during the holiday season... this time I had no wig, no beard and no red suit...but he knew me as Santa! Who's challenged?

As the Executive Director of a large retirement community, I always welcomed contact with our residents. One day as I worked at my desk, Mrs. Ruffin came shuffling through the door. She was a tiny and endearing little lady who immediately put a death grip with both of her hands on my left wrist. "Oh, Mr. Williams," she asked, "Do you remember when I first moved-in and my toilet was over-flowing and wouldn't work and you came up with the maintenance man and got it all straightened out? Well now for all these years it's been working perfectly and every time I look at that toilet I think of you!" Uh...thanks, Mrs. Ruffin...I think!
